# ELKINS COMMON COUNCIL REGULAR COUNCIL MEETING MINUTES

Virtual July 16, 2020 7:00 p.m.

Elkins Common Council met in regular session virtually. Present were Mayor Van T. Broughton; Councilpersons R.C. Chenoweth, M. D. Cuonzo, C.H. Friddle, III, J.A. Guye, G.M. Hinchman, C.C. Lowther, C. ### **PRESENTATION**

Katy McClane and Logan Smith gave a presentation on behalf of Elkins Make It Quiet. The organization provided a petition signed by nearly 200 residents from throughout the city stating that "We, the undersigned, believe that the constant machine noise – 24 hours a day, six days a week- emanating from Hamer Pellet Fuel mill in Elkins, West Virginia, is unacceptable noise pollution, and a public nuisance. It is diminishing the quality of life, health and property values of the surrounding community and businesses. We respectfully request Hamer's urgent action to be a good neighbor: enclose the offending machinery or use absorptive noise barriers to contain the noise within Hamer's property." EMIQ also provided six written testimonials and audio samples to council. The group, which formed in 2019, is asking the city to intervene in any way they can to help abate the noise and air pollution and protect the rights of its citizens.

For the purpose of clarity during this audio-only virtual meeting the Clerk was directed to conduct a roll call vote for every matter of business a vote was called for.
