ELKINS COMMON COUNCIL REGULAR COUNCIL MEETING MINUTES

401 Davis Avenue Council Chamber, 2nd Floor December 3, 2020 7:00 p.m.

Elkins Common Council met in regular session in the council chamber of city hall. Present were City Clerk J.R. Sutton (acting as Mayor); Councilpersons R.C. Chenoweth, M. D. Cuonzo, C.H. Friddle, III, J.A. Guye, G.M. Hinchman, C.C. Lowther, C. L. Metheny, D.C. Parker, L.H. Vest, and K.L. Wilmoth; City Treasurer T. Judy; Fire Chief T. W. Meader; Police Lt. R. Belt; Operations Manager R.P. Pingley; City Attorney G. S. Roberts; Executive Secretary C. Boggs (acting as recording secretary); and Inter-Mountain Reporter B. Johnson.

Mayor V. Broughton and Police Chief T. Bennett were absent.

PUBLIC COMMENT

Shannon Campbell, 330 Graham Street, stated that the first she had heard of the proposed UTV ordinance was that very morning on her local radio. She expressed her opposition to the proposed UTV ordinance, citing her concerns with the repercussions of such action.

Nanci Bross-Fregonara, 210 Boundary Avenue, spoke in opposition to the proposed UTV ordinance. She agreed with Ms. Campbell's comment, adding that she had read about a poll in the Inter-Mountain newspaper that surveyed local residents on their opinion of the agenda item which reflected that the majority would be against such measures. She urged council to reconsider. She would like to see it taken back to the Rules and Ordinance Committee.

Matthew Ogden, 1510 S. Kerens Avenue, feels that the UTV ordinance is widely misunderstood and is being misconstrued. He urged everyone to consider the benefits and asked that those who abide by the laws and operate their UTV's legally not be penalized for the action of others. He concluded by stating that he felt the ordinance would not result in as much change as many were suggesting.

Burley Woods, 522 Davis Street, stated that he did not feel we should discriminate against our residents when we allow motorcycles and other types of vehicles that can produce similar noise, and when neighboring areas allow some UTV usage. He feels that excluding Elkins is a mistake and that locals should be permitted the same rights as others.

Susan "Sue" Phares, 23 High Street, stated that she felt noise pollution is becoming more prominent within Elkins. She feels that in addition to UTV's contribution to this existing issue, she is concerned for the safety risks associated with the proposed ordinance. She suggested that

perhaps a compromise could be reached by recognizing and authorizing alternative routes for users.

Ron Hite, Central Street, stated that he felt our area law enforcement is incapable of monitoring existing illegal activity and questions how they would be able to successfully enforce the proposed UTV ordinance. He stated that he does not agree that there is any benefit to come from its passing.
