PRESENTATION

Logan Smith, Deputy Director, and Lucas Ray, Communications and Partnership Manager, provided information about the Appalachian National Forest Heritage Area (ANFHA) becoming a National Heritage Area in 2019. The ANFHA serves 18 counties in WV and MD who share similar forest heritage and history. A large component of the AFNHA is the AmeriCorps program. This consumes 18% of their budget and has one of the most visible impacts on communities. Moving forward the AFNHA is developing a National Heritage Management Plan through collaborative meetings. The plan will help guide the organization in it's mission, including historic preservation, cultural conservation, natural and recreation access, education and interpretation programs, tourism and economic development. Mr. Smith showed great appreciation for the City's partnership and support. Several current and past AFNHA

Seth Young of the Augusta Heritage Center promoted advocacy and awareness to council about this asset to the community. The Augusta Heritage Center, started in 1973 at the Tygart Hotel and moved to the campus of D&E in 1981 in an effort to preserve traditional Appalachian arts. Now, the organization sees participants and online members from all 50 states and over 25 countries. Mr. Young and assistant Emily Miller, with the help of an AmeriCorps member are digitizing years of audio recordings and pushing content out online. The Augusta Heritage Center is offering a number of events this summer and fall and are expecting a large turnout from people all across the country and world. One focus moving forward for Augusta is to increase opportunities to partner with the community and bring August downtown.
