PRESENTATION

Fire Chief S. Himes presented information to council on the recent Insurance Services Office (ISO) evaluation and rating completed on the Elkins Protection System. The evaluation was completed on October 25, 2021 and the score was receive din early May 2022. There are four main criteria on which the scoring is based. They include emergency communications, fire department, water supply and community risk reduction. Chief Himes supplied the scores for each area as well as a historical reference. The ISO uses a rating system of 1 (best) to 5 (worst). In 1986 EFD was class 5. In 1991 and 2017, they were a class 3. EFD will remain a class 3, but the Chief sees potential areas of improvement which may move the city to a class 2 rating in the future.
